Special Consideration Decision Matrix

Applications for Special Consideration must be on the grounds listed below and will not require evidence for 1 day (in teaching Terms) or up to 3 days (in teaching Sessions), but where requests are for periods longer than this, the evidence below will be required.

a	HEALTH	<p>Medical Certificate, from relevant health practitioner, which includes:</p> <ul style="list-style-type: none">- the date on which the student was examined;- a statement of the date/s the student was impacted <p>For additional days not covered by the medical certificate a Statutory Declaration is required</p> <p>If a student has not been able to attend a medical appointment, a Statutory Declaration may be considered, where it explains the nature of the health matter, why they have not been able to obtain a medical certificate, and the duration of impact.</p> <p>Covid 19 (from 24.01.22-30.04.22)- If a student is unable to provide a Medical Certificate or a Statutory Declaration, due to covid, we will accept an email stating that they cannot complete an assessment task or come on campus for assessment task related work due to COVID or related isolation requirements, for extensions up to 3 days in Terms and 5 days in Sessions. A screenshot of the pathology notification by text, of the PCR result, that shows the date it was taken, and the positive result with the Students personal details.2. The submission notification, where a student has had a positive Rapid Antigen Test, and notified their State Government.		<p>Student is impacted by their own health matters - Medical certificate showing time impacted by health matter, and if the certificate does not cover the due date or exam date, then an additional Statutory Declaration to explain further impacted dates.</p> <p>Student Impacted by another persons health matters, such as close family member or partner - A medical certificate if available showing dates impacted, and a statutory declaration explaining why a medical certificate could not be obtained, the relationship and details of impact.</p> <p>For Covid 19 - A Screenshot from a phone or email, from the Pathology Laboratory showing the date the swab was taken, Student Name, Date of Birth, Positive result.</p> <p>A copy of the acknowledgement of submission of a positive result from the Rapid Antigen Test, to a State Government Health website, showing the Student Name and the date submitted.</p>
b	COMPASSIONATE CIRCUMSTANCES (Misreading a due date will not be considered grounds for Special Consideration)	<p>An official document that corroborates the nature of the event, showing dates of impact relevant to the special consideration being sought for the assessment item.</p> <p>For compassionate circumstances related to someone other than the student, a Statutory Declaration is required that outlines the nature of the matter being considered for Special Consideration, the dates of impact and the relationship to the student.</p>		<p>Death of a close family member - Funeral notice, or Order of Service, indicating dates</p> <p>Death of non-family member :Requires Funeral notice / Order of Service indicating dates and a Statutory Declaration outlining relationship and therefore impact.</p> <p>If impacted by Domestic Violence or other Police matter , a Police Report number or a Statutory Declaration stating high level information of the nature of the matter, and the dates of impact.</p>
c	RELIGIOUS OBSERVANCES OR CELEBRATIONS	<p>Statement signed by an authorised officer of the appropriate organisation which validates that the date/s of the commitment corresponds with the date/s for which special consideration is requested.</p> <p>Where a signed statement is not available, a Statutory Declaration detailing the impact of the Religious Observances or celebrations on meeting the deadline for assessment, or exam date.</p>	<p>Application submitted 1 month prior to event; if extenuating circumstances a Statutory Declaration is required to explain why notice is less than 1 month.</p>	<p>If an Exam or presentation falls on the day of significant religious day that prevents you attending or participating, then a Statutory Declaration is required stating the relevance of the event, the date of the event and the impact on the student.</p> <p>Eg, a wedding to be attended, Jewish Passover, Ridvan</p>
d	SERIOUS UNFORSEEN PERSONAL EVENTS (Misreading a due date will not be considered grounds for Special Consideration)	<p>An official document that corroborates the nature of the event, showing dates of impact relevant to the special consideration being sought for the assessment item.</p> <p>If an official document is not available or the reason is in regard to a person other than the student, a Statutory Declaration is required that outlines the nature of the matter being considered for Special Consideration, the dates of impact and the relationship to the student.</p> <p>Covid 19 (from 24.01.22-30.04.22)— If a student is affected by a person contracting Covid other than themselves, and they have caring responsibilities for this person, the University will accept an email stating this is the case for extensions up to 3 days in Terms and 5 days in Sessions. Subsequent and extension requests beyond this will require evidence as follows:</p> <ol style="list-style-type: none">1. A screenshot of the pathology notification by text, of the PCR result, that shows the date it was taken, and the positive result.2. The submission notification, where a student has had a positive Rapid Antigen Test, and notified their State Government.		<p>For all of the following a Statutory Declaration including impacted dates will be required, where no other official documentation is available.</p> <p>Natural Disasters, such as Bush Fires, or Flooding.</p> <p>Impacts from Covid 19, such as sudden lockdowns or border closure.</p> <p>Family Members being impacted by Covid 19.</p> <p>Technology breakdowns, that results in lost work.</p> <p>Sudden serious accident involving the student or someone other than the student</p> <p>For Covid 19 - A Screenshot from a phone or email, from the Pathology Laboratory showing the date the swab was taken, Patient name, Date of Birth, Positive result. The student must then include on the Special Consideration form, the relationship to the person who has the positive result.</p> <p>A copy of the acknowledgement of submission of a positive result from the Rapid Antigen Test, to a State Government Health website. The student must then include on the Special Consideration form, the relationship to the person who has the positive result.</p>
e	SELECTION IN STATE, NATIONAL OR INTERNATIONAL SPORTING / PERFORMANCE EVENTS	<p>Statement signed by an authorised officer from the appropriate organisation to validate the date/s of the commitment for which special consideration is requested.</p> <p>If a signed statement is not available, a Statutory Declaration detailing the event, the dates involved, and the impact on the student in regard to the assessment.</p>	<p>Application submitted 1 month prior to event; or if extenuating circumstances a Statutory Declaration outlining the reason for the shorter notification.</p>	<p>For all of the following a Statutory Declaration including impacted dates will be required, where no other official documentation is available.</p> <p>Representation at State level for a particular sport.</p> <p>Requirement to participate in a Performance event.</p>
f	Rendering genuine and unforeseen emergency service in a professional or voluntary capacity; or rendering any service (including undertaking training) in the Defence Reserves	<p>Statement signed by an authorised officer from the appropriate organisation to validate the date/s of the commitment for which special consideration is requested.</p> <p>A Statutory Declaration if a signed statement is not available detailing the event, the dates involved, and the impact on the student in regard to the assessment.</p>	<p>Application to be submitted as early as possible once the commitment is known</p>	<p>For all of the following a Statutory Declaration with the impacted dates will be required, where no other official documentation is available.</p> <p>Voluntary Service in the SES to attend a natural disaster, or other event.</p> <p>Service in the Defence Force to attend a national or state emergency, or compulsory training.</p>
