## **Teaching Methods and Teaching Arrangements**

These Teaching Methods and Arrangements apply to all coursework units unless exemptions are endorsed by the relevant Associate Dean (Education) and approved by the Pro Vice-Chancellor (Academic Innovation) on the basis of the following reasons:

- 1. documented and justifiable external accreditation requirements exist;
- 2. there is a demonstrated need to manage risk for clinical placements, internships, work integrated learning, and other external learning experiences, or for preparation for laboratories; or
- 3. a strong pedagogical rationale can be articulated which remains consistent with the Assessment, Teaching and Learning Policy.

Supervision	A structured teaching method involving one-on-one or small-group oversight by an academic or professional supervisor. Supervision supports student learning through guided reflection, feedback, and mentoring, typically in the context of research, professional practice, or project-based work. It facilitates the development of discipline-specific knowledge, critical thinking, and professional capabilities through regular, personalised engagement. Residential	An immersive in-person learning experience at a specific location (on campus or at a designated venue) for a set period over multiple days.  During a residential, students typically participate in face-to-face sessions that cannot be replicated online.
