



Academic Misconduct Guidelines

This document provides guidance to Academic Integrity Officers and the Dean of Graduate Studies in deciding penalties regarding academic misconduct.

These Guidelines apply to all University students and should be read in conjunction with the Rules - Student Academic and Non-Academic Misconduct Rules (the Rules).

Guidelines

Decision-makers (Academic Integrity Officers and the Dean of Graduate Studies) will investigate allegations of academic misconduct, and determine penalties and/or orders in a fair and equitable manner and in accordance with the Rules and these Guidelines.

Decision-makers should apply the following principles when determining an appropriate penalty:

- Educative: Has the student had the opportunity to learn how to practice academic • integrity in the University context? For example, a small amount of plagiarism in a student's first session could be considered of lesser significance than for a student in later years.
- *Progressive:* What is the nature and extent of the academic misconduct and what is the student's history of academic misconduct? For example, if a student was found to have small amounts of plagiarism in two assignments, even after having received a caution on the first assignment, it may be appropriate to refuse a resubmission and either give the student a zero for the assignment or a fail for the unit.
