Abbreviated title:	Dip'field/discipline abbreviated'	
Example:	Diploma of Business Management - DipBusMgt	
Associate Degree A	QF Level 6	
Award title:	Associate Degree of 'title reflecting field of study/discipline', or Associate Degree of 'title reflecting field of study/discipline' in 'specific area'	
Abbreviated title:	AssocDeg 'field of study/discipline ' or 'field of study/discipline in specific area', usually abbreviated	
Example:	Associate Degree of Indigenous Studies - AssocDegIndigStudies Associate Degree of Business Administration in Purchasing - AssocDegPurchasing
